## 2 Protection of personal data and privacy

The VCSVU takes good care of proper security and careful processing of your personal data. In doing so, the VCSVU hereby adheres to the conditions set out in the European privacy law “General Data Protection Regulation (GDPR)”, also known as the “Algemene verordening gegevensbescherming (AVG)”.

The VCSVU handles the personal data provided by registering as a member, sponsor or alumni, registering for a VCSVU event or requesting information. The personal data provided is stored by the VCSVU. This data is not published or sold to third parties.

### 2.1 Data capture and security

Membership data will be processed in Congressus, the program the VCSVU uses to manage memberships, bank account details and the VCSVU site. In addition, e-mail addresses, first and last names are stored in Google Contacts and Mailchimp.

### 2.2 Processing of personal data

The VCSVU can process your personal data because you use the services of the VCSVU and/or because you provide it to the VCSVU yourself. The personal data is processed for the purpose of processing payments, sending the weekly e-mail, sending invitations for General Members Meetings and other information facilities. In addition, you can be contacted if this is necessary to be able to carry out our services.

The VCSVU can process the following data:

- First and last name
- Sex
- Date of birth
- Address data
- Phone number
- E-mail address
- Bank account number
- Study
- Student number
- Photos

In addition, dietary requirements and allergens can also be generated in specific cases. This information is only requested when this is necessary for an event where food is served.

The personal data will not be kept longer than necessary to achieve the purposes for which your data was provided to the VCSVU. The data will be kept as long as you are a member, "begunstiger" or alumni of the VCSVU. An exception to this is the storage of photos taken during VCSVU activities; these are kept for ten years and during this time can be viewed on the VCSVU website and are only visible to people who can log in to the VCSVU website. After these ten years, the photos will be kept in the archive of the VCSVU, the board of the VCSVU manages this archive. The photos on the site may be used for promotional purposes. These photos are then published on Instagram and Facebook, and are removed after three years.

The VCSVU only provides data to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation. When you are a member of the VCSVU, you are automatically also a member of the Royal Dutch Pharmaceutical Students Association (K.N.P.S.V.). The VCSVU shares names and e-mail addresses of members with the K.N.P.S.V.

## 4 Activities

When registration is necessary for an activity of the VCSVU, this registration is binding. This means that when a member registers for an activity of the VCSVU, the member is also expected to participate in that activity. If, after registration, a member, patron or alumnus is unable to come to the activity for whatever reason, they must deregister no later than 48 hours after registration

via the above-mentioned correspondence details, provided that the registration deadline has not expired. In special occasions the VCSVU board can make exceptions.

## 5 Deregistration

If you stop studying Pharmaceutical Sciences, the master Drug Discovery and Safety or the master Chemistry, it is your responsibility to deregister from the VCSVU. If you deregister from the study, your membership will not be automatically terminated. You can unsubscribe by filling in the unsubscription form on the VCSVU website (click [here](#) for the form) or by e-mailing to [info@vcsvu.nl](mailto:info@vcsvu.nl).

The association year runs from September 1 to August 31. Members who unsubscribed after August 31 will be charged a membership fee. They can then use their membership until the end of the association year.

After registration with the VCSVU, the contribution will be debited at least once. It does not matter whether a member deregisters before 31 August. When a member registers before starting the study (Pharmaceutical Sciences or Drug Discovery and Safety), the member will only pay can be left out for the association year in which the member starts studying.

When you cancel your membership, you may be asked for permission to save your name and e-mail address, so that you can contact us for alumni activities

## 6 Collaboration with the VCSVU

When a collaboration is started between the VCSVU and a third party, agreements are made that both parties must adhere to. These agreements are linked to the collaboration in order to prevent or resolve disputes if a dispute does arise.

### 6.1 Requesting a collaboration

When a third party is interested in entering into a collaboration with the VCSVU, this party can request a brochure with more information about possible collaborations via the above correspondence address. If this party is interested in a collaboration, a quote can be requested. After receiving the quotation, there is a period of four weeks in which to accept or reject the quotation.

### 6.2 Implementating a collaboration

After accepting the offer, an invoice will be drawn up by the VCSVU containing the agreements that have been made regarding the collaboration. The invoice must be paid within four weeks after approval. If the invoice has not been paid after these four weeks, a reminder will be sent twice with a request for payment. After these reminders, the VCSVU will take appropriate action to still receive the amount to be paid.
